Coordinated Entry

Agencies are doing a terrific job embracing the coordinated entry system. We have nearly 800 VI-SPDATs entered into HMIS and many family VI-SPDATs that have been administered and are awaiting entry. Our hope is that the VI-F-SPDAT will be in HMIS soon. ADOH is monitoring turnover in projects to make sure that providers are prioritizing those with the most acute needs for

PSH. We know that coordinated entry and ensuring equal access to services regardless of which provider a client initially contacts, will lead to a significant reduction in the number of individuals and families experiencing homelessness. Thank you for all of your hard work in adopting this new process. Please remember to ALWAYS check the VI-SPDAT prioritization list for your county before

accepting a client into your project. If a client with a higher score is on the list, you should be looking at that client for entry. If you need help running the report, contact CIR at:

AZ Fair Housing Partnership

The Arizona Fair Housing Partnership was developed in March of 1998 by a group of organizations concerned with improving fair housing awareness in Arizona. On January 16, 1999, in commemoration of the Reverend Dr. Martin Luther King, Jr., sixteen (16) organizations signed the first statewide Fair Housing Partnership Resolution Agreement. The first statewide fair housing summit was sponsored by the Partnership on April 7, 2000, Fair Housing Month. The Partnership has sponsored such a summit (now called Symposiums) every year in the month of April since 2000. The Symposiums touch on an array of topics, some controversial such as medical marijuana and desperate impact, but all informative, relevant, and timely. Booths are also set up at various

celebrations and community fairs to distribute information to housing consumers and housing professionals regarding fair housing. The AZ Fair Housing Partnership is a clearinghouse for information and assistance to those in need.

With the implementation of the new HUD Data Standards last year, we have been working with providers to address data quality issues brought about by the changes in data collection. Agencies utilizing HMIS should run data quality reports **monthly** to ensure that the agency is up-to-date on the collection
