## **Discussion Topics**

- The outline need to be filled in with procedures, responsibilities, and duties
- Karia struggles with the guidance group; however, with all of the decisions that have to be made the importance of the group has become clearer
- The board would, among other things, decide what to do with funds that were designated for a
  construction project that was not funded by ADOH; HUD did not recapture these funds but
  instructed ADOH to use for another program
- Karia discussed trip to Washington and the conference held by COSCDA which is a conference for all state agencies that administer CDBG, HOME, and other federal grants
- Dave Wolf volunteered to be the chair and Jessa Johnson volunteered to be the secretary
- Barbara agreed to share Tucson's COC Policies and Procedures with the group
- The decision was made to work as a group for the purpose, mission, and goals portion of the guidance
- The question was asked if we are developing policies for local COC and BOS two tiers. Not all
  counties have a local COC so how would we do that; we should have relationship building first
- Mohave and Yuma will not have a problem adopting the Policies and Procedures because they have an active COC what are the local COCs discussing about homelessness? Are there any actions going on?
- Yuma deals with RHBA a lot and uses their documents and other materials if someone could speak a Yuma COC regarding what they need to do that would be helpful
- We should work on purpose, mission and goals with the local COCs
- We need to define the board should they be recipients? One should be an ESG recipient, a formally homeless person, etc.; these are decisions we need to make
- How do we start with the purpose, mission, and goal?
- Gina needs the HEARTH Interim rule to know what HUD outlined
- There are three primary goals
  - o Operate a COC
  - o HMIS

- Planning
- Planning grant of \$47,000 could be used for scholarships, trainings, and go to meeting sessions
- To operate a COC as outlined by HUD
  - o Conduct biannual meetings
  - o Invite new members annually
  - Appoint sub-groups
- We need a formal process of inviting new members to show we are doing the above
- Yuma lacks business participation but has all the other local attendees required; the FEMA board is the same group; we need to tap into the local FEMA groups
- Dave we need to look at GA COC since it is a state agency with a BOS
- Joy will send out the TPCH's policies and procedures
- Cochise County is starting up again, Navajo and Apache Counties are building up again, La Paz advisory council meets; we have help with the count but no one has stepped up to host the COC. Maybe we can tap into the advisory council.
- Gina may put something on their agenda
- Next step: think about purpose and mission, limit goals; look at two or three different mission statements from other state BOS
