Update on development of Emergency Transfer Plan Policy and Procedure to use across	Cristina	<p>Cristina provided an overview and examples about emergency transfer situations that have recently taken place. The three CoCs are working on a statewide policy so there is consistency across the state about how emergency transfer planning is implemented.</p>

Update on AHCCCS H2O waiver prioritization	Cristina	<p>Cristina provided an overview of the AHCCCS H2O Partnerships with local health and behavioral health networks are important. AHCCCS is requiring that their providers begin participating in the LCEHs. The H2O program will start October 1st. Conduct HUD CE Assessment-Self Assessment Tool was included with agenda email	Cristina Members	<p>Cristina discussed the BNL and indicated that Solari is soliciting feedback about updates to how make the list more user friendly. Randy indicated that LCEHs can contact Solari to discuss issues.</p> <p>Cristina led a discussion through the Coordinated Entry Process Self-Assessment. Highlights included</p> <ul style="list-style-type: none"> • Several LCEHs shared the number of access points. Based on information provided, access points are available throughout the AZBOSCOG. • Chris Moeller shared that the Coconino Supplement to the VISPDAT – was developed to address three issues: returns to homelessness, disparities, and the high percentage of households that are survivors of domestic violence. Chris also indicated that they have question to address possible interviewer bias for some attributes. • WACOG mentioned that they have a first time homebuyers program which has extended their options for move-on. • ESG programs are collaborating with the LCEHs. • Gila reported that they have outreached to Forest Services and Firewise teams as these individuals are interacting with individuals who are homeless and camping in the forests or other areas. • Kelly Tanner – AZYP indicated that they have a dedicated youth drop-in center in Kingman, and they are using Facebook, Instagram, and Snapchat to outreach to youth. They work closely with schools and many youth they interact are coming out of foster care. • Many of the counties are collaborating with various veterans programs for outreach and engagement. • Pinal LCEH has a dedicated website and also has a mobile outreach team. Pinal is also working with law enforcement related to outreach. Red Cross is a good partner in Pinal. • Apache/Navajo , through the ReCenter is doing events for outreach as do other LCEHs.
