Under Arizona State law there is the Landlord and Tenant Act, which pertains to renters in Mobile Home Parks.

The Mobile Home Parks Residential Landlord and Tenant Act which pertains to standard rental housing was enacted to govern the rental of dwelling units and the rights and obligations of landlord and tenant. The document can be downloaded for free. There is currently no state agency that enforces provisions in the Act, and because most landlord/tenant relations are private transactions, disputes that arise between landlord and tenants are generally considered private matters
