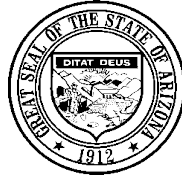

**ARIZONA'S MANUFACTURED HOUSING INSTALLATION PROGRAM
2023 TRAINING REQUIREMENTS**

ADOH Installer Licensees:

Each current ADOH licensee (Qualifying Party) must participate in a Manufactured Housing & Building Division ("MHBD") approved training as a condition of licensure.

Each licensee is responsible to submit certificate of completion of the approved MHBD training options and/or proof of attendance for Chapter meetings, MHI or AHA event to the Department's E-Licensing Solution System at time of license renewal.

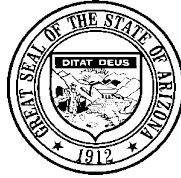
