Please complete this form (fillable form online) or complete the form using black ink, and return the completed form with a check or money order for the non-refundable processing fee of fifty dollars (\$50) to the Department of Housing ("Department"). By providing all of the requested legible information, you will ensure prompt processing of your complaint. Should you prevail, the Administrative Law Judge's Order may require the opposing party to reimburse this fee. The State of Arizona Department of Housing does not charge any additional fees for this hearing. However, should this matter proceed through the appeal process to the Superior Court, the court may award attorney's fees to the prevailing party.

All notices, orders, and other communications from this Department regarding the case will be mailed to you ("Petitioner"), and it will be your responsibility to ensure that any other Petitioners listed on the form promptly receive notice of such communications.

Upon receipt of the form and payment of the \$50.00 processing fee, the Department will process your Petition by requesting a response from the Owner/Manager ("Landlord") of the Mobile Home Park. The Landlord has twenty (20) days to respond to the Department. The Department will contact you upon receipt of the response from the Landlord.
