During Covid, funds became available to increase the availability of shelter and housing throughout the AZBOSCOC. Many of the projects were available when the count took place in January 2024 which allowed for a increase in the number of persons sheltered. The AZ Department of Housing leveraged additional state and Federal funds to expand capacity. Hotels to Homes projects are in process in some areas of the AZBOSCOC.

A few pocket shelters did not provide information for this year\\'s HIC, but a few new previously non-participating projects have engaged with our county Local Coalitions/Continuums to End Homelessness which coordinate AZBOSCOC local activities within the 13 counties within the AZBOSCOC geography. Examples of these include Crossroad Mission in Nogales (Santa Cruz County) and Hope House in Sedona (Yavapai County). These are not only new projects in PIT/HIC reporting but represent newly coordinated resources in communities that had not previously been participating in CoC activity.

Overall, the AZBOSCOC count went well this year from 1349 in 2022 to 1206 in 2023, a 10.6% reduction. .

The Local Coalitions to End Homelessness provided comprehensive coordination. The CoC level PIT workgroup met regularly to discuss strategies for implementation. Training was provided locally in person and a virtual CoC-wide training took place. LCEHs were able to get incentives donated locally. The number of volunteers across the AZBOSCOC also increased this year from 262 in 2022 to 309 in 2023.

The AZBOSCOC has established additional Local Coalitions to End Homelessness (LCEH) in two counties which facilitated the count process. Volunteers increased from 262 in 2022 to 309 (18%) increase. Training was provided locally and virtually. A CoC wide PIT Workgroup met regularly. Incentives were provided through local contributions.
