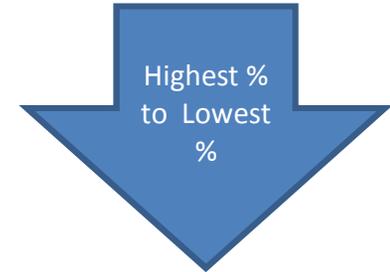


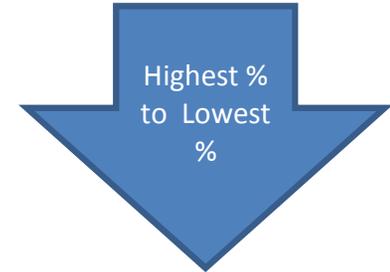

FEBRUARY 2012 REVENUE BREAKDOWN
