#### Call to Order

The meeting was called to order at 10:04am by Glennifer Mosher. Minutes from April 5, 2017 were approved. Motion was made by Cristina Benitez, seconded by Skye Biasetti. Unanimous yes vote.

# CIR Report on Data Quality

Michelle and Shantae attended the HMIS data conference in Salt Lake City last week. HUD is developing a new quality framework, a tool that the Continuum will need to help everyone look at their data quality and system performance measurements. Data will be directly reported into the Sage system. As long as the data quality is under a 5% error rate, HUD is okay with it.

The report will now show the timeliness of data being entered. Data should be entered within 7 days. Interims also need to be completed. The timeliness affects overall numbers for reports such as the AHAR. Areas of data that need to be worked on are social security numbers, veteran status, income at entry, annual assessment and exit. Length of stay for certain program types, such as street outreach and emergency shelter, should not be long-term. Those programs with longer stays might have to reconsider their program type.

ADOH will be creating a form that agencies will fill out with the grade on our agency report cards and send back to ADOH bi-monthly. The grade will need to be 98% or higher. HUD is looking to cut funding and low performing continuums could receive less funding if numbers are low.

## Coordinated Entry- Revisited

When you have a client who needs housing, the first thing you do in HMIS is go to the "enter data as" and put them in coordinated entry, entering in this order: 1) Household, 2) ROI, 3) Entry/Exit, 4) VI-SPDAT, 6) Service Transactions-Referrals.

Referrals need to be done in coordinated entry. You can check the box that will send an email to the agency being referred to.

ADOH is considering adding a statement to the ROI that states that other agencies participating in case conferencing might have access to clients' information. The full list of agencies would be posted on the ADOH webpage.

### New APR

The current (old) APR will be used until July. Anyone in HMIS can pull APR reports even if you do not receive CoC funding. Those with contracts send their APR's to ADOH every year with their program information. The new APR will be submitted through SAGE. If data changes are made, it will show the changes immediately when you run your report. Currently, you have to wait a day for the changes to show on the reports. On the new APR, live links will appear as blue. It will show any errors and how quickly data is being entered. Agencies should still run the detailed APR because the new APR is still being worked on. If you have a contract with ADOH, run your reports and ADOH will upload it and send it to HUD. If you receive money directly from HUD, agencies will upload the reports and send them to HUD. Annual assessments need to be updated. Any missing or partial data comes up as an error. Chronic Homeless numbers are being looked at by HUD. If you serve a lot of chronic clients, email ADOH and let them know how many chronic specific beds you have in your programs.
