### Clarifications

Safe havens are not emergency shelters and there are none currently in Arizona. Make sure if you are checking safe haven as an entry or exit, that it is actually a safe haven.

Once an individual enters in to transitional housing, they are no longer considered homeless. The VA housing programs may be allowed to keep homeless status if it was under 90 days. CIR will check on this and get back to the committee with the answer.

### New CoC APR- #0260

The new APR is located on the dashboard under reports. You need to have an ART license to run the companion APR. APR's need to be run every other month.

ADOH does not want to see any errors. Timeliness will also be recorded. The annual assessments should be completed within 30 days. When completing income updates, click on interims, do not edit current information and never delete the old income. Under interim updates, end the current income and then add the new income.
