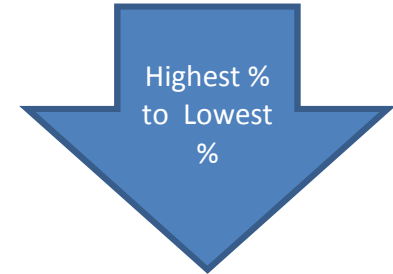
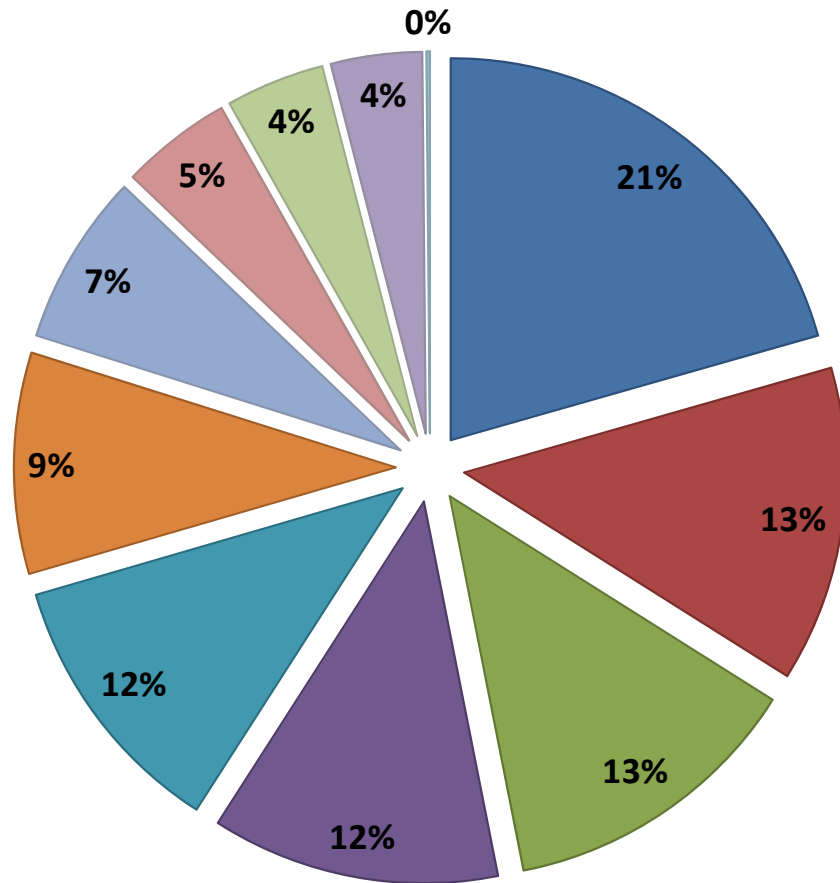

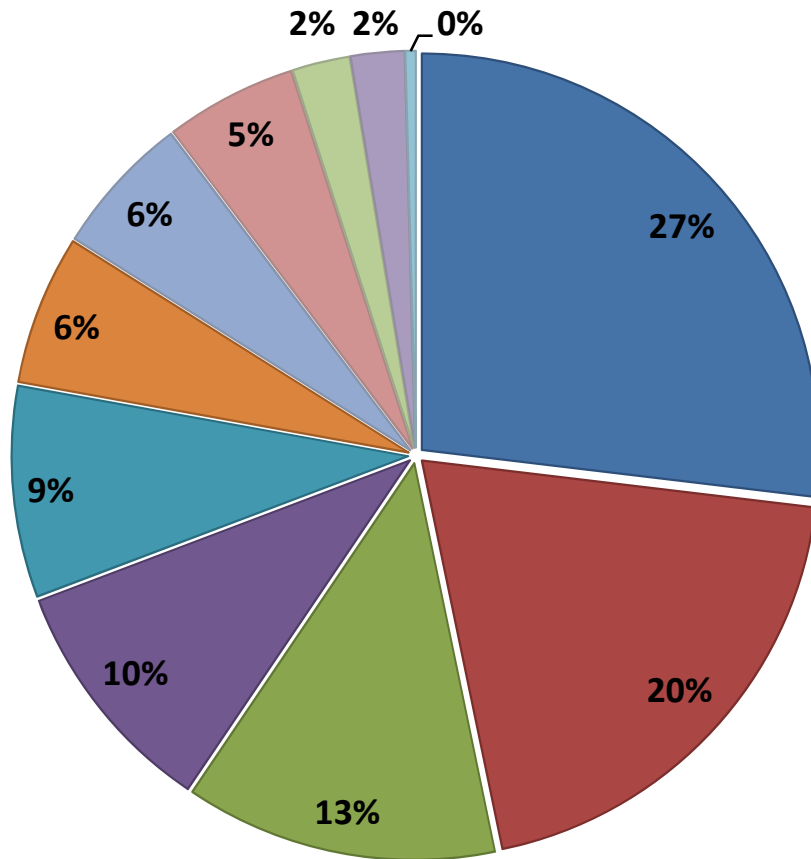
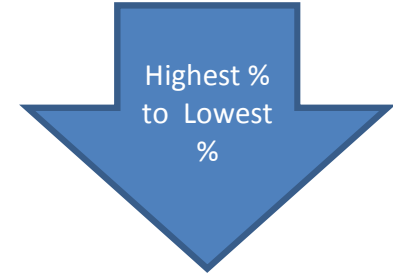
JUNE 2012 REVENUE BREAKDOWN
