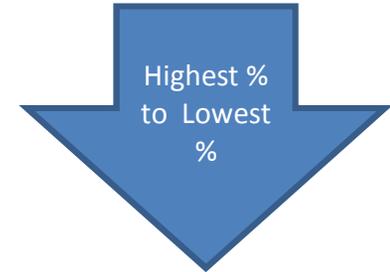
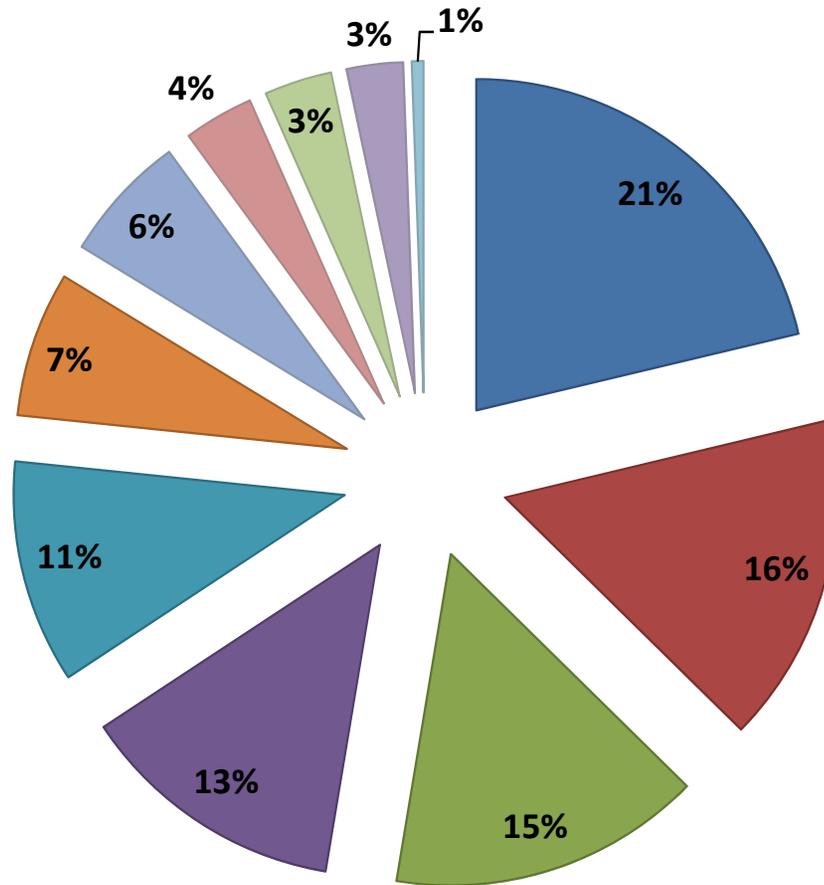

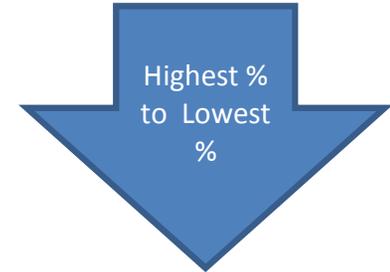
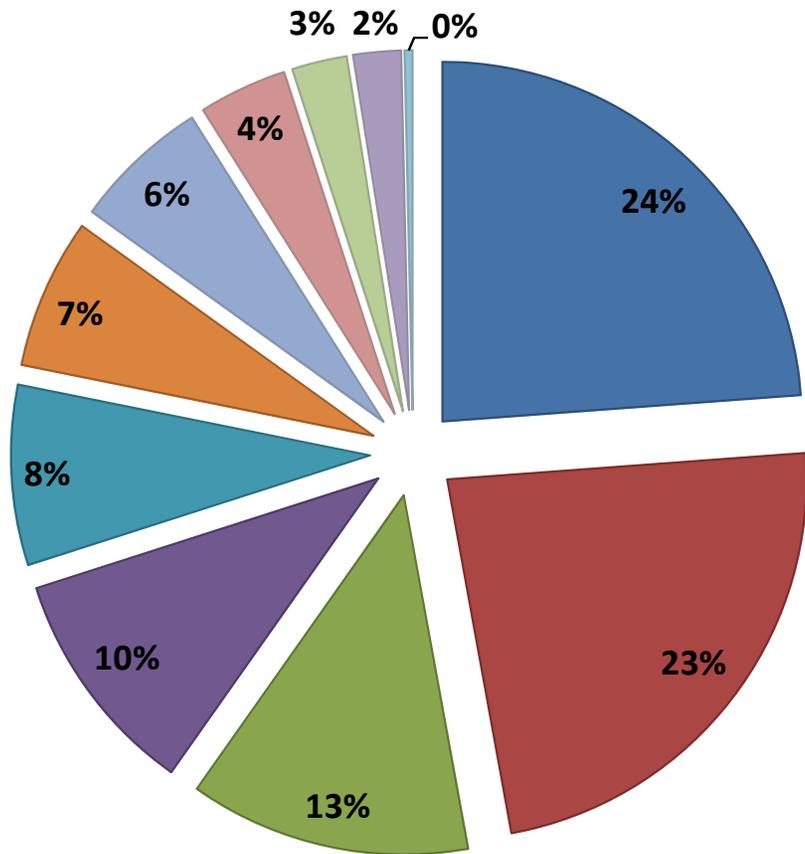
MAY 2011 REVENUE BREAKDOWN
